**BY-LAW SECTION RE DELEGATE ENTITLEMENT ARTICLE IV**

**Section 4** Representation at meetings shall be on the following basis: from affiliated local unions, branches and lodges, two (2) delegates for one hundred (100) or less members, and one (1) additional delegate for each additional one hundred (100) members or major fraction thereof, but no local union, lodge or branch shall be allowed more than eighteen (18) delegates.

(a) The organizations cited in Section 4 shall be entitled to an equal number of alternates based on the representation formula.

**Section 5** The number of members of each organization for the purpose of selecting delegates to the Council shall be the average monthly number on which per capita tax is paid.
